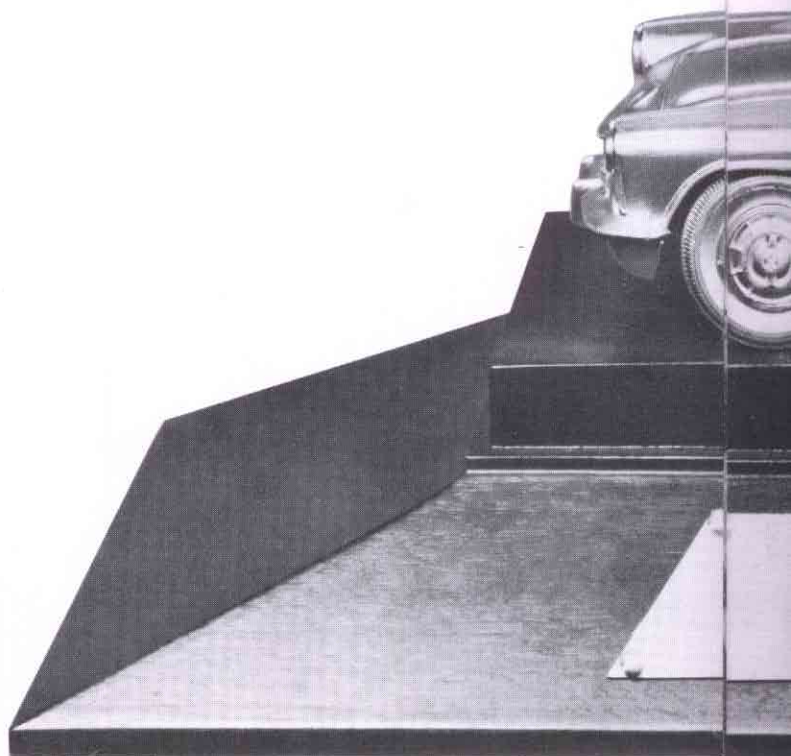
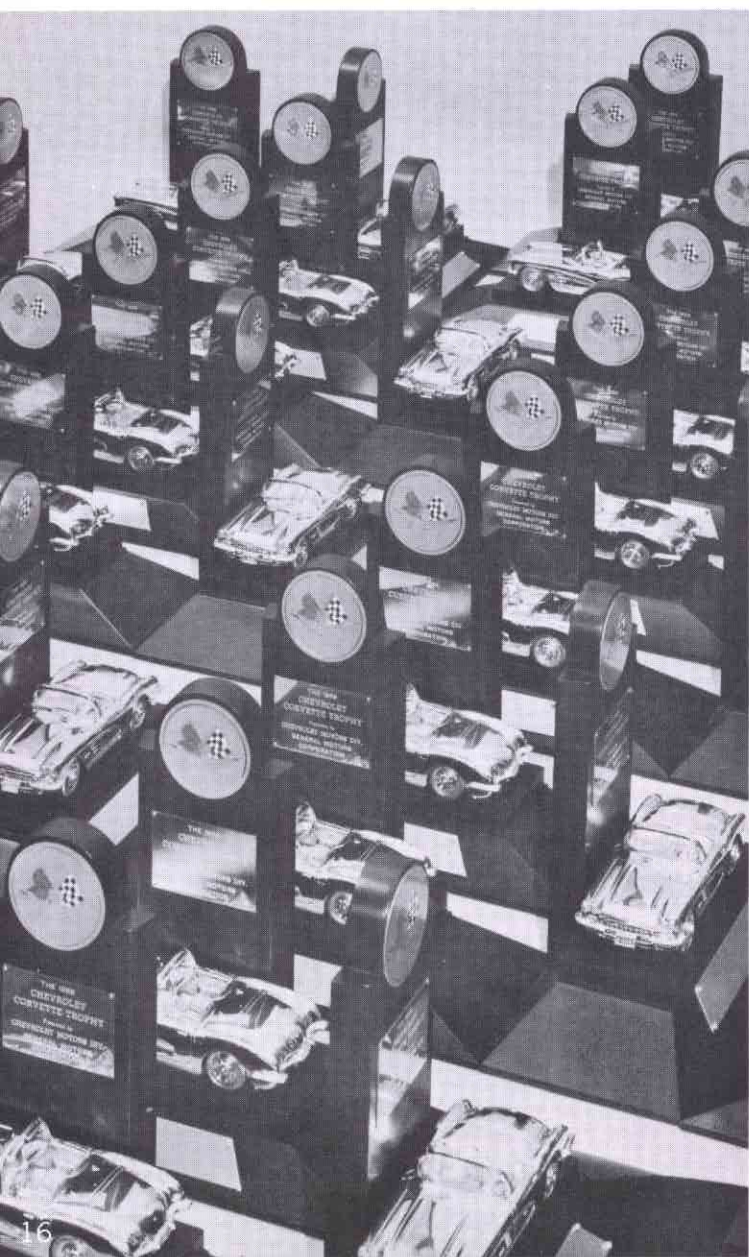
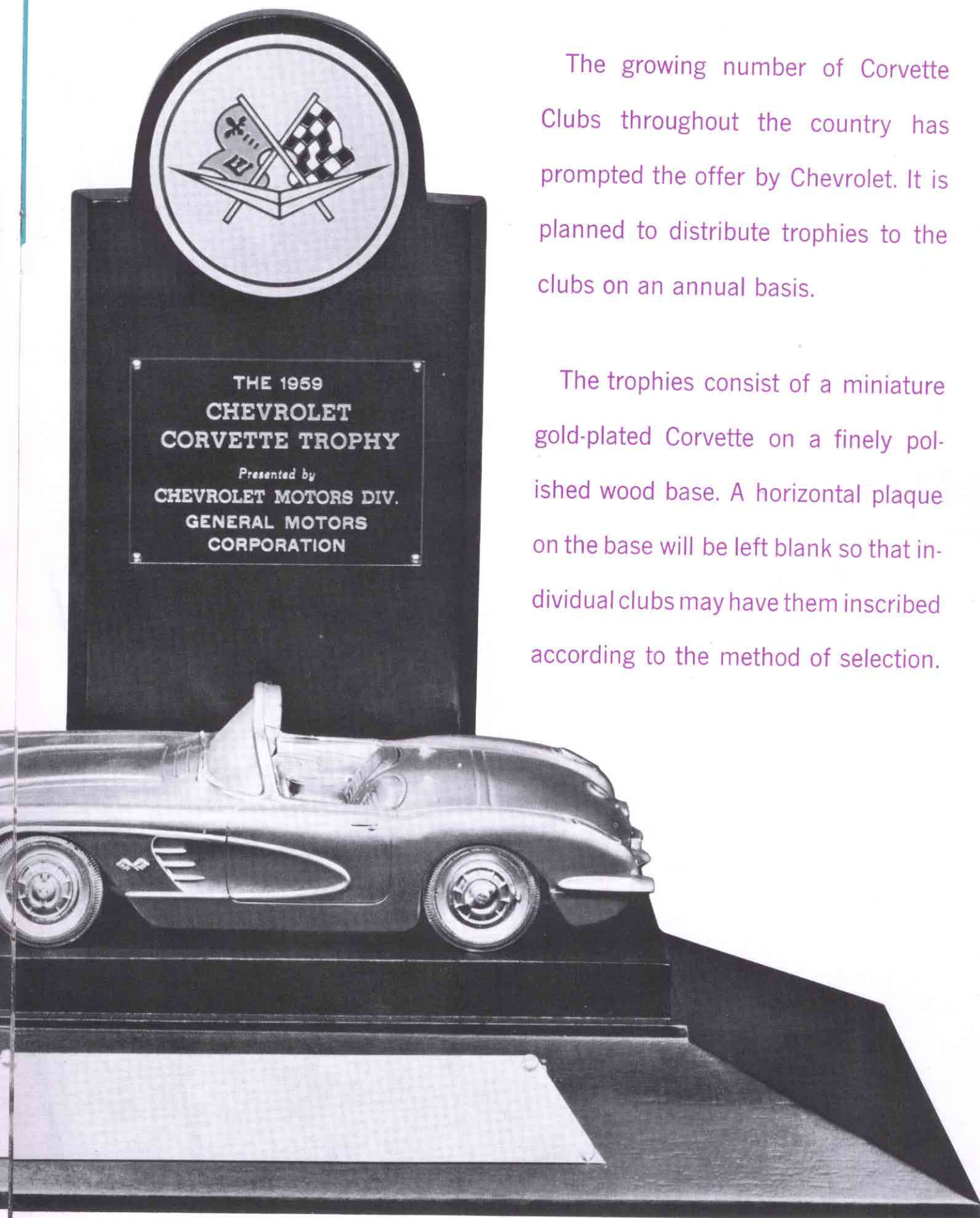


# CHEVROLET GIVES **TROPHY** TO CORVETTE CLUBS

A handsome new trophy will be presented to all Corvette Clubs across the United States by the Chevrolet Motor Division this year. Each club will be allowed to select its most deserving member to receive the award on any basis the club sees fit. Possible selections might be based on service, driving skills, or all-around contribution to the Corvette Club.





The growing number of Corvette Clubs throughout the country has prompted the offer by Chevrolet. It is planned to distribute trophies to the clubs on an annual basis.

The trophies consist of a miniature gold-plated Corvette on a finely polished wood base. A horizontal plaque on the base will be left blank so that individual clubs may have them inscribed according to the method of selection.
